


## By 2030 eThekwini will be Africa's most caring and liveable city

#### Homelessness

The term "homeless" refers to someone who is usually poor and frequently on the move from one temporary dwelling situation to another. Many slang words are used to describe such a person: *squatter*, *hobo*, *vagrant*. Homeless people live in various spaces, under freeway overpasses, sleeping in parks, dilapidated buildings, subway tunnels, on sidewalks, etc.



# City Reclaims Its Public Spaces by Conducting Major Clean-Ups.

In an effort to root out crime and grime, eThekwini Municipality has intensified its daily multi-disciplinary enforcement operations to clear and clean-up areas in the Municipality that have been taken over by homeless people.









## Challenges facing the policing of illegal squatting in parks

- According to Section 24 of the Constitution of Republic of South Africa Act 108 of 1996, the purpose of protecting a park is to provide clean air for the public and to conserve nature for future generations.
- Squatters in these areas becomes a problem because they do not have the necessary infrastructure for healthy living, which includes decent housing, electricity, refuse removal, sanitation and water supply.
- Squatters often cut down trees in parks in order to make fires, and carry out activities regarded as offensive in public spaces e.g. washing their clothes & bathing.





#### **Improving Parks & Open Spaces**

#### Major clean-up campaigns

- □ Clear-cutting overgrown brush
- Encouraging private property owners to secure vacant lots and buildings
- Removing street furniture
- Managing feeding scheme for homeless people
- Working with land use enforcement officers
- Fencing open spaces
- Removal of debris

The 7 Pillar Intervention:

- Outreach and Reception Services
  Screening and Psycho Social Support
  Treatment and Rehabilitation
  Skills Development & Employment Opportunities
   Identity Documents and Birth Registration
   Reunification and Reintegration
   Shelters and Halfway Houses
- Part of the Clean My City Campaign aimed at addressing social ills that exist in the Albert Park area in order to make it safer, cleaner and more attractive.
- Municipality aims to eliminate vagrancy, loitering and drug-abuse in the Albert Park area. Various intervention strategies have been identified.



#### **Intervention at Bulwer Park – Case study 2**



- □ 'Heart of the Park' a multi-functional space was designed.
- Upgraded playground areas to generate a' child and parent destination: 'Play with Art'.
- **Create an amphitheatre**
- Create an attractive pedestrian movement system

Bulwer Park Upgrade is a pilot project of the municipality's Sustainable Public Spaces Program which directly supports the Integrated Development Plan's (IDP) Quality Living Environment Plan.



'Bulwer Park is retained as a valuable green space that offers opportunities for recreation, conservation and attractive creative spaces for community events, that will complement the site and create a unique identity reflective of the surrounding uses and community aspirations.'

#### The following deliverables was implemented:

- Multi-purpose footpath
- Outdoor gym equipment
- New lighting, benches, bins and drinking fountains
- □ Removal of selected exotic trees, tree lifting and pruning



#### Quality Living Environmental Plan: Congella Park

- Landscape design and improved functionality and aesthetics
- Addressing homelessness in Congella Park by educating people, keeping the park neat & clean and enforcing by-laws.
- Installing toilet and shower facilities for the transient poor.
- □ Service be charged at nominal rates.
- Restaurants and shops buying fresh vegetables could also donate food to the poor.



#### Learning from NGO's: Denis Hurley Centre



- □ Serves the needs of the poorest people of Durban.
- □ Honour and co-operate with people of all faith traditions.
- □ Welcome South Africans, migrants and refugees.
- Offer services through their clinic, feeding scheme, vocational training, educational and community support, and pastoral outreach.
