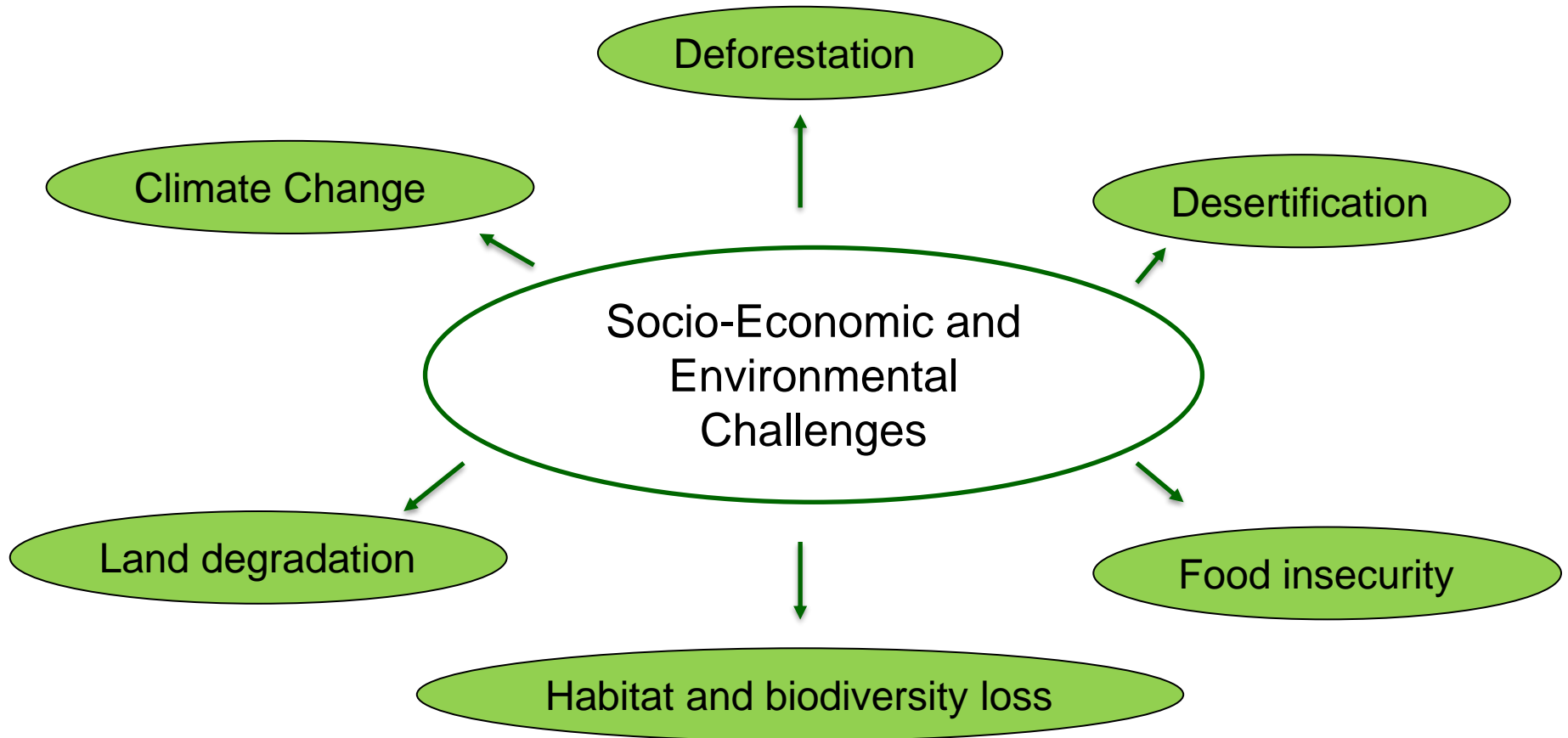

BACKGROUND



GREENING I

Greening is a function of the Dept of Forestry, Fisheries and the Environment (DFFE)

- It is a form of Community Forestry as defined in the NFA Chapter 4
- It is spearheaded by DFFE in partnership with various stakeholders
- It rolls out at local level & therefore it has to be in local plans (IDP's) & other related plans
- It supports Priority 5 of the 2019-2024 MTSF – Spatial Integration, Human Settlements and Local Government

GREENING II

Greening is the planting, care and management of all vegetation types in urban and rural areas, to secure multiple benefits for residents” (*National greening strategy ,2006*)

Targeted areas include:

Cities, townships and informal settlements/ low-cost housing or new development areas.

- Greening follows an integrated approach, mainly focusing on parks, streets, open spaces, green belts, cemeteries, as well as homesteads.

GREENING III



- From **A Million Trees to Ten Million Trees**: A call by the Office of the Presidency of SA – (2020)
- Ten Million Trees planted over five (5) years
- Ten Million Trees Programme Aims to:
 - To create sustainable settlements in South Africa
 - To mitigate the effects of climate change
 - To provide food security
 - To provide and/or enhance recreation facilities
 - To provide green infrastructure services i.e. promotion of biodiversity, storm water control, local temperature control, soil and wind erosion minimization, wind breaks
- Anchors of the Ten Million Trees Programme, - **The Arbor Month Campaign**, - **The National Arbor City Awards**, - **School Greening**, - **Trees for Homes**

NATIONAL ARBOR CITY AWARDS (NACA)



It is a greening competition for municipalities – initiated in **2002**

It is led by DFFE: Forestry Management Branch and sponsored by TotalEnergies

Other key partners – **the Institute of Environment and Recreation Management (IERM) and the South African National Biodiversity Institute (SANBI)**

It has four categories:
Metropolitan; Local; Small Rural Local Municipality and Youth Participation in Greening.

To promote the Ten Million Trees Programme

To ensure compliance with relevant environmental legislations

To raise awareness on the importance and value of trees in residential settlements

To promote greening of the country in general

To provide a platform for diagnosis of challenges facing municipalities regarding greening funding and also to discuss solutions.

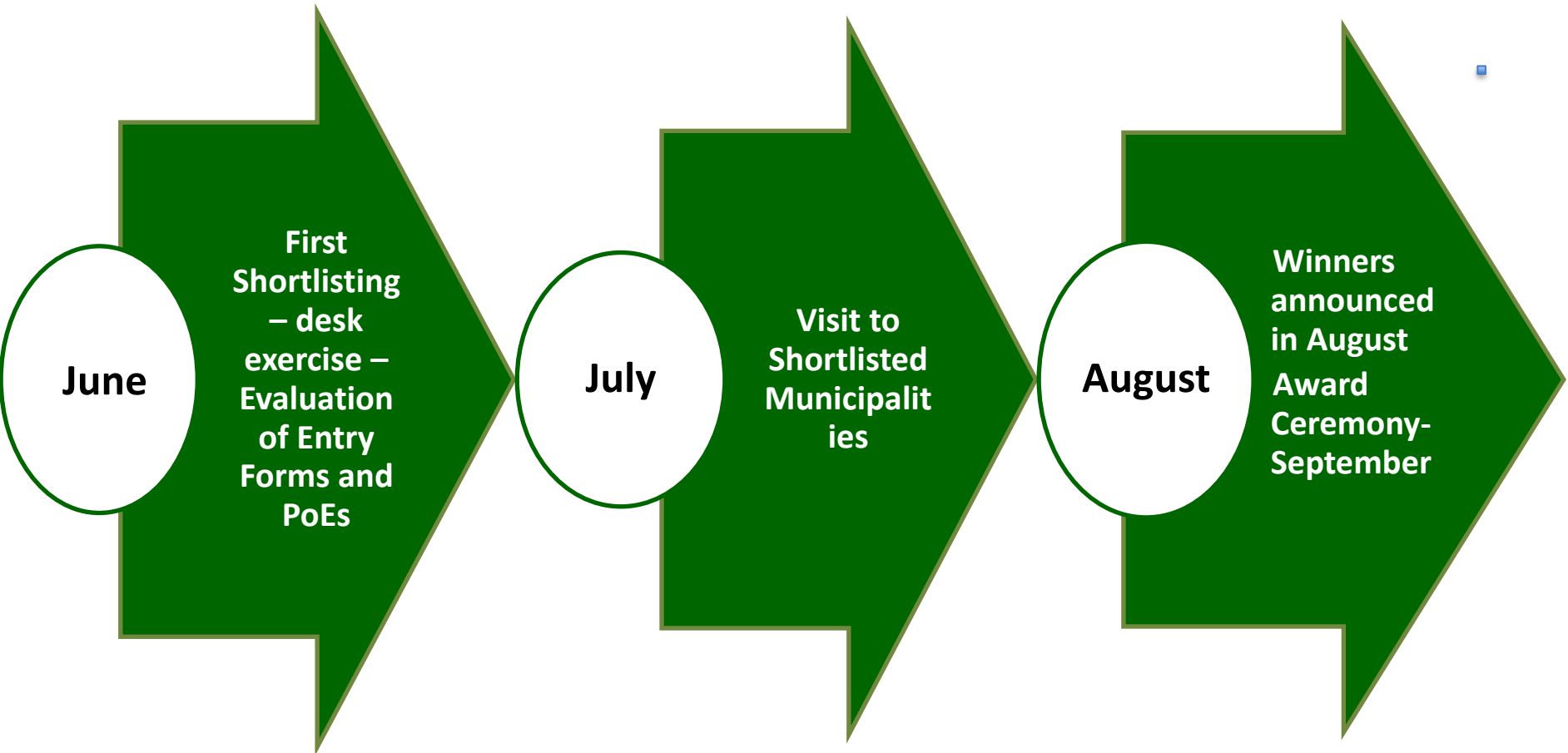
